Vendor Rules

1. Vendor Booth Fees are \$50.00 and are non-refundable. Booth spaces are 10' by 10' or 12' by 12'. Larger spaces are available upon request.
 - a. Vendor's Fee must be paid in full at time of booking. Vendors not paid in full will not be allowed to set up.
2. No selling of Foods or Drinks of any kind will be permitted!
Vendor Set Up Time
 - a. You must check in at the Team/Vendor Registration Area prior to setting up.
3. **Access to Electrical Powder**
 - a. Equipment needing electricity will be provided at an added cost.
If electrical outlets are required, someone will be on hand to assist you.
Please specify on the application form what type of voltage you will need to hook up your electrical needs.
4. If you are bringing a trailer and leaving on premises, give the size of the trailer _____.
5. The vendor is responsible for cleaning up of their booth space before leaving. There will be a dumpster provided for vendor's disposal of boxes, trash, etc.
6. This is an **Outdoor Cook-off** Exhibitors must provide their own shelter, tables, chairs, displays, and all supplies such as tape, scissors, etc.
7. We are not a bank and cannot provide cash or change during the Cook-off.
8. **Exhibitors are responsible for paying state (4%) and parish (4.5%) sales tax. We will supply you with the proper forms and you are responsible for filing them.**
